Location: Townlands Carrickayne, Legnahappoge, Glengarrow, Stroanback and Doorat, 4KM North East of Plumbridge.

Proposal: Intention to Submit an Environmental Statement for proposed Mullaghclogher Wind Farm comprising up to 12 three bladed wind turbines, each up to a maximum of 180m tip height associated external electricity transformers; underground cabling; a newly created site entrance; access tracks; turning heads; crane hardstandings; control building and substation compound, battery energy storage containers, off-site areas of widening to the public road and all ancillary works. During construction and commissioning there would be a number of temporary works including a construction compound with car parking; temporary parts of crane hardstandings and welfare facilities.

I refer to the above and your letter dated 29 September 2023 indicating that you intend to submit an Environmental Statement for the above proposal.

As required by Regulation 9(4)(iii) of the Planning (Environmental Impact Assessment) Regulations (NI) 2017, I enclose a list of the District Councils and other authorities likely to be concerned by the proposal by reason of their specific environmental responsibilities or local or regional competences. These bodies have been advised of your name and address and of their duty under Regulation 10(1) of the Regulations to make available to you information in their possession which they or you consider relevant to the preparation of the Environmental Statement. You are strongly advised to consult these bodies.


Schedule 4 to the Regulations sets out matters to be included in any Environmental Statement. You should note that the onus is on the developer to demonstrate the
